We will study proper methodology in finding air leaks, identifying energy thieves, and will clearly illustrate how such improvements will save energy. We will cover the use a blower door and Zone Pressure Diagnostics (ZPD) so that the analyst will be able to identify and prioritize air sealing requirements. This advanced training will allow the analyst to completely identify deficiencies within the envelope and plan to make the upgrades to seal the envelope. will be thoroughly explained and each participant will go into the field and perform testing on a building of their choosing.
