

HANDS-ON BASIC ELECTRICITY FOR OILHEAT TECHNICIANS

OVERVIEW

This three day *Basic Electricity* and *Oilheat Controls* course is provided to offer students with an entry-level understanding of electricity and controls. The electricity portion of the course will cover the following topic areas:

- How electricity works
- Line 1 – Neutral & Ground
- Types of Circuits
- Electrical Distribution and Codes

The *Oilheat Controls* portion of the course will cover the following topic areas:

- Honeywell Controls
- Switching Relays
- Low Water Cut Offs
- Burner Primary Controls

Lab time will focus on wiring basic control circuits and trainer models of warm air furnaces and hot water boilers.

Once the information review is completed a *test will be administered* at the completion of the class. All materials are included in the cost of the class.
