

RINNAI TRAINING

OVERVIEW

This one day training is a hands-on complete tear down class conducted by **Mark Hellen** and **Shawn Doughty** of *Nelson & Small, Inc.* The training will be broken into morning and afternoon sessions. Shawn will be teaching the morning session focusing on Rinnai's water heater, while Mark will teach the afternoon session focusing on the direct vent heater portion of the course.

Topics covered will include:

- **VENTING** – lengths and clearances
- **INSTALLATION** – where to place units, clearances
- **OPERATION** – how it works
- **SERVICING** – how to properly do OHMS and voltage readings, understanding error codes and how to troubleshoot the unit.

This training will include work on (6) Ductless Direct Vent Heaters and (6) Water Heaters in MTEC's state of the art training facility. There will be no more than (3) people per unit.

If you do not have a Rinnai Certification Number, these training sessions will allow you to sign up for one. We will provide screwdrivers and meters. If you would like to bring your own meter for your own comfort level, please feel free to do so.
